## NFL POSTSEASON CREDENTIAL APPLICATION PROCEDURES AFC AND NFC DIVISIONAL GAMES

(Saturday and Sunday, January 14-15): Credential requests for the AFC and NFC Divisional Playoff Games should be made to the public relations director of the home team.

#### **AFC AND NFC CHAMPIONSHIP GAMES**

(January 22): To apply for credentials to the AFC and NFC Championship Games, go to www.NFLmedia.com and click on the NFL Event Credentialing link, which will take you to the online registration form. The deadline to apply is Tuesday, January 10, 2006. Credentials can be picked up at the media headquarters hotels in the host cities. The hotels that will serve as media headquarters for the AFC and NFC Championship Games will be announced on www.NFLmedia.com in early January. NO CREDENTIALS WILL BE MAILED. Credentials will be issued at the media headquarters beginning at noon (game-site time) on Friday, January 20. Each media member must present a governmentissued photo identification (passport, driver's license, etc.) at credential pickup. Those credentials not picked up at the media headquarters will be available at Press Will Call the day of the game and will require presentation of government-issued photo identification.
